REGULAR AGENDA

1. CHAIR REPORT

Board Chair Jeff Aalfs reported that he will appoint a Liaison and one or more Alternate Liaisons to the Citizens Advisory Committee at the October 22, 2020, Board meeting.

2. CEO REPORT

Chief Executive Officer Jan Pepper provided an update on staffing, Board subcommittee meetings, and meetings with Commissioners of the CPUC (California Public Utilities Commission) and CEC (California Energy Commission). She reported that Peter Levitt presented a webinar at the CalCCA (California Community Choice Association) Community Energy Innovation webinar series on resilience with solar+storage.

3. REVIEW DRAFT BOARD RETREAT AGENDA

Jan Pepper reviewed the draft agenda for the Board Retreat taking place the morning of Saturday, September 26, 2020. She reported that due to the virtual nature of the meeting, the retreat is being made shorter and will take place from 8:30 a.m. to 12 noon. She reported that detailed reports will be provided in the agenda packet so that presentations during the retreat will be more high-level.

The Committee discussed Retreat agenda items and plans for a future discussion of power purchasing.

4. DISCUSS CURBSIDE CHARGING PROGRAM

Director of Energy Programs Rafael Reyes reported that the Curbside Charging pilot program uses streetlights to provide access to EV (Electric Vehicle) charging. He reviewed the key issues being evaluated prior to selection of Curbside Charging sites, the objectives and costs of the pilot phases, and the timeline. Committee members discussed the phase costs, equity in the location of chargers, and city budgets.

Online Chat:

Donna – If we are going to do this, then I think that there should be a push to help our underserved communities and support their staff in making these decisions.

Rafael - Thank you Director Colson. We will be looking at underserved communities closely Rafael - Director Colson, I'm now noting your interest in Burlingame's possible participation in the Curbside pilot. We will circle back with you.

Donna - Thank you - and I will check with Kevin if maybe we are already doing this in our Rollins Road specific plan. Maybe we can cover the cost and just use PCE in an advisory capacity. Thanks all - I am learning a lot about all of this.

5. DISCUSS CONSTRAINTS FOR ORGANIZATION AND EVENT SPONSORSHIPS

Director of Marketing and Community Affairs KJ Janowski reviewed three options that would restrict sponsorship of events and memberships of organizations that endorse or oppose political candidates and/or political initiatives.

Committee members discussed the options and came to a general consensus supporting Option 1: Restrict sponsorship or membership to organizations that do not endorse or oppose political candidates.

6. REVIEW EXISTING BUILDING ELECTRIFICATION INCENTIVES

Rafael Reyes reviewed residential appliances involved in existing building electrification, natural gas emissions sources in the County of San Mateo, and the programs roadmap for existing building electrification. He outlined and compared the costs and incentives for water heating retrofits and space heating retrofits.

Committee members discussed the cost of panel upgrades, the Harvest Thermal pilot, and the pros and cons of providing incentives for heat pump water heaters versus heat pumps for heating and cooling.
